



## Privacy Notice for Members, Parents and Carers

### **What type of information we collect**

We currently collect and process the following information:

- Personal identifiers, contacts, and characteristics (for example: - name, address, date of birth and contact details)
- Key person information and contact details (including parents, carers, emergency contact, social workers, doctor and pharmacist)
- Details of support received, including preferences, behaviour, support needs and care packages
- Details of external assessments such as social care assessments or health protocols
- Life history such as past education, individual circumstances, social networks and key events
- Photographs and videos, including CCTV footage

We may also collect and process the following **'special category'** information:

- Details of medical conditions, including physical and mental health
- Other health information such as allergies, dietary needs and general health and fitness
- Medication information
- Safeguarding information
- Details of gender, race & ethnicity

- Religion and beliefs
- Sexual orientation and/or history

On rare occasions, and with your consent, we may also process other information not listed above.

### **How we get the information and why we have it**

Much of the personal information we process is provided to us directly by you or your carers for one of the following reasons:

- To fulfil or establish a service agreement
- To enable us to provide suitable care and support

We also receive personal information indirectly, from the following sources in the following scenarios:

- From social workers and other health bodies, to enable us to establish and fulfil a suitable service agreement and protect the vital interests of members
- From health professionals such as doctors, nurses and specialists, to safeguard the health needs and vital interests of members
- Via CCTV footage on our premises

We only collect and use members' personal data when the law allows us to. Most commonly, we process it in order to:

- Fulfil a service contract
- Provide appropriate care and support
- Protect member health and welfare
- Monitor and report on member progress
- Assess the quality of our services
- Comply with the law regarding data sharing
- Comply with the law regarding health and safety and investigate following accidents and incidents

Less commonly, we may also process members' personal data in situations where:

- We need it to perform an official task in the public interest, or to protect public health
- We have obtained consent to use it in a certain way
- We need to protect the individual's vital interests (or someone else's interests)
- We need to respond to legal claims
- We have a legitimate interest that justifies our processing, such as when a crime is suspected

Where we have obtained consent to use members' personal data, this consent can be withdrawn at any time by contacting Jade Nolan.

Some of the reasons listed above for collecting and using members' personal data overlap, and there may be several grounds which justify our use of this data.

We may share this information with:

- Our local authority – to meet our legal obligations to share certain information with it, such as safeguarding concerns
- Member's family and representatives
- Suppliers and service providers – to enable them to provide a service we have contracted them for
- Central and local government
- Our auditors and regulatory bodies
- Health authorities and social welfare organisations
- Professional advisers and consultants
- Police forces, courts, tribunals

### **How we store your information**

Your information is securely stored at one of our premises, via secure cloud storage and/or via care management software.

We keep information for the duration of your service agreement, plus an 8 year retention period. We will then dispose of your information using shredding, incineration, deletion of digital files, and other methods as appropriate.

### **Your data protection rights**

Under data protection law, you have rights including:

**Your right of access** - You have the right to ask us for copies of your personal information.

**Your right to rectification** - You have the right to ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

**Your right to erasure** - You have the right to ask us to erase your personal information in certain circumstances.

**Your right to restriction of processing** - You have the right to ask us to restrict the processing of your information in certain circumstances.

**Your right to object to processing** - You have the the right to object to the processing of your personal data in certain circumstances.

**Your right to data portability** - You have the right to ask that we transfer the information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
